IT PROVIDES A CONTINUUM OF CARE INCLUDING STREET OUTREACH, EMERGENCY SHELTER, CASE MANAGEMENT SERVICES, PREVENTION SERVICES, TRANSITIONAL HOUSING, AND PERMANENT SUPPORTIVE HOUSING. IT SERVES APPROXIMATELY 4,000 ADULTS, VETERANS, FAMILIES, AND YOUTH EACH YEAR AT SEVEN LOCATIONS INCLUDING THE BOCCARDO RECEPTION CENTER, WHICH IS THE COUNTY'S LARGEST HOMELESS SERVICES CENTER. IN ADDITION THE ORGANIZATION MANAGES TWO COLD WEATHER SHELTERS, ONE IN SUNNYVALE AND ONE IN GILROY, FOR AN ADDITIONAL NIGHTLY CAPACITY INCREASE OF UP TO 230 SPACES DURING THE MONTHS NOVEMBER THROUGH MARCH.
